Grass cutting contractor changed for this new financial year 2016/17. Sterling job done previously by parishioner Dick Martin. . Village Grass Cutting done by HDC only 4 times last year therefore some money were saved. 4.5 Budget was run by Cllr Simonis till new Clerk appointed. Budget for this new Financial year 2016/17 is 4.6 £5,122.00. Precept raised by 4%. Traffic calming - Minor Improvement scheme run last year. 4.7 New Transparency code in progress. Top priority this year for PC is a website – as it is a legal obligation now. 4.8 Footpaths are well looked after by Cllr Troughton.
